M.A	Origin of European Philosophy	3	3	This course aims to explore the ideologies of Europe in 18th and 19th centuries.
M.A	Theory of Institutions and Organizations of EU	3	3	This course explores the nature of EU institutions and organizations from both a theoretical and an empirical perspective.
M.A	International Politics of Europe	3	3	This course enables the students to comprehend the core issues of European security and foreign policies with a focus on the past, present, and future of NATO and UN.
M.A./Ph.D.	Cultural Policy in the EU and European Identity	3	3	This course deals with the EU's evolving cultural policy with special reference to the issue of European identity
M.A./Ph.D.	Politics of European Countries	3	3	This course reviews the history of political systems of EU countries and assess the future political integration of Europe.
M.A./Ph.D.	European Integration and Law	3	3	This course explores the treaties between member countries and the principles and laws of EU which are the basis of integrated Europe.
M.A./Ph.D.	A Seminar on European Politics	3	3	We discuss and study political issues at hand in Europe applying theoretical perspectives to the issues.
M.A./Ph.D.	Political Economy of Europe	3	3	The aim of the course is to study the theoretical and conceptual tools that will help make sense of international political economy, international economy and European economy.
M.A./Ph.D.	History of European Economy	3	3	This course studies the history of economic development in European

				region with a focus on the cooperation and integration.	
M.A./Ph.D.	Economic Integration of European Union	3	3	This course is aimed at enhancing participants' basic understanding of the process of economic and monetary integration of Europe and also at providing both theoretical and empirical insights into the economic rationale of such integration processes.	
M.A./Ph.D.	Industrial and Trade Policy in European Union	3	3	With this course, we study theories of industrial and trade policies and then apply them to analyze the industrial and trade policies in practice of EU member countries.	
M.A./Ph.D.	European Economy at State's level	3	3	This lecture is aiming at enhancing participants' basic understanding of the process of economic development as well as the contemporary economic situations in the European countries, for both member and non-member countries of European Union.	
M.A./Ph.D.	European Financial Market	3	3	This course aims to help students be equipped with the background knowledge on the development and current status of European financial markets. The course treats issues on private sector financial markets as well as the role of central banks and governments in relation with monetary policies.	
M.A./Ph.D.	A Seminar on European Economy	3	3	This course reviews the economic policy and development of major European states. The historical development of economic systems and their change are as well discussed as the challenges for economic policy today.	
M.A./Ph.D.	Labour Market in Europe	3	3	This course discusses theoretical approaches to the labour market and their application to labour market policy and enables the students to analyze the European labour market by giving them the necessary tools of analysis.	
M.A./Ph.D.	Understanding Europe and Europeans	3	3	Through methodology of sociocultural studies we study Europe and Europeans. We analyze culture of individual countries to understand multiculturalism and intercultural communication in European union.	
M.A./Ph.D.	Integration and Social Change in Europe	3	3	This course considers the 'social' aspects of the history of European integration from social policy, to the social chapter of the Maastricht Treaty, to current debates about a 'social Europe' and the enlargement of the EU.	
M.A./Ph.D.	Social Policy of European Union	3	3	This is empirical research seminar. This seminar considers social dimension of the European Union, crisis of welfare state, and reform of social policy in EU and its member states.	
M.A./Ph.D.	Nations and Religions in Europe	3	3	General overview and understanding of nations and religions in Europe is the basic aim of this lecture.	
M.A./Ph.D.	Integration and Culture of Europe	3	3	This course is aimed at enhancing participants' basic understanding of the culture code and business culture in Europe. And we discuss the relationship between the integration and cultural changes.	

M.A./Ph.D.	A Seminar on European Sociology	3	3	This seminar introduces European studies to the field of sociology with special emphasis on globalization, and helps students to consider the sociological dimension of their individual research areas in connection with its possible economic, political and legal aspects.
M.A./Ph.D.	Central and Eastern European Diplomatic History	3	3	This course surveys the history of the foreign policies of the countries of Central and Eastern Europe by concentrating on the competition between the east and the west during and after the Cold War. It also considers the decision-making processes in the field of foreign policy in the various Central and Eastern European countries.
M.A./Ph.D.	Political Systems and Institutions of CEECs	3	3	After Soviet Destruction, Central and Eastern European countries carried out so-called double conversion system reforms summed up as political reform and economic reform. They brought in democracy system such as constitutional government, free election, multiparty system in new political environment. Also, they have been establishing market economic system based on a justification of private ownership. This course will consider the introduction of Western-style democracy in CEECs after the end of communism. The political systems and power relationship between the national organizations of these individual CEECs will also be studied.
M.A./Ph.D.	Foreign and Security Policy in CEECs	3	3	This course will discuss the major issues of diplomacy and security in CEECs both during and after the Cold War era with special emphasis on NATO and the WTO (Warsaw Treaty Organization).
M.A./Ph.D.	Seminar on Politics of CEECs	3	3	This course will enlarge the range of students' understanding of the geopolitical situation of CEECs by discussing the major changes since the end of the Cold War, e. g. the eastward march of NATO and the enlargement of the EU. Especially, consideration will be given to restructuring of cooperation in the fields of economic and national security such as GUUAM, CBSS, BSEC, CEFTA, the Visegrad Group, and the TRACECA project that have sprouted in Central and Eastern Europe since the end of the Cold War.
M.A./Ph.D.	Economic History of CEECs	3	3	This course offers a comprehensive survey, both from theoretical and practical viewpoints, of the economic histories of the CEECs, including the problems of the former communist economic system, the evolution of economic policies after the collapse of the soviet-type plan economy up to the accession of some of these countries into the European Union, in order to give students the intellectual basis to be able to make sense of economic events of the day in the CEECs.
M.A./Ph.D.	Theories on CEECs Economies	3	3	This course considers important economic issues in CEECs, with the emphasis on the erstwhile transition experiences and more recent accessions to the European Union.
M.A./Ph.D.	Investment Environment in	3	3	This class will consider the determinants of economic development in

	CEECs			Central and Eastern Europe. Especially, the focus will be on country studies on foreign direct investment, transformation, and development.	
M.A./Ph.D.	Seminar on CEECs Economies	3	3	This course will analyze the domestic and foreign economic actions of the countries in Central and Eastern Europe in which students are interested. Topics considered will include the reorganization of the Central and Eastern European economic order, economic cooperation, market reform in each country, the economies of those countries that have already joined the EU, and the prospects of joining for candidate countries. Also consideration will be given to foreign direct investment with special attention given to the present situation of the investment of Western capital.	
M.A./Ph.D.	Culture and Religion in CEECs	3	3	After the end of the Cold War, Europe was divided into "East" and "West" by the "iron curtain," and geopolitically Central Europe was included in Eastern Europe to distinguish it from Western Europe. However, in the post-Cold War era, the rediscovery of Central Europe has been sought based on cultural and religious identities rather than on geographic boundaries. Thus, on the one hand, Central Europe includes catholic countries such as the former Habsburg (Austria-Hungary) Empire and Poland. On the other hand, Eastern Europe includes orthodox countries such as Russia, Ukraine, Rumania, and Bulgaria. This course will search for the points of similarities and differences in Central and Eastern European culture based mainly on religious criteria.	
M.A./Ph.D.	Social Structure and Social Change in CEECs	3	3	The purpose of this course is to grasp the social structures and processes of social change in the countries of Central and Eastern Europe, and induce correct understanding and interest about Central and Eastern Europe escaped from previous Western-tendentious views.	
M.A./Ph.D.	Seminar on Society and Culture of CEECs	3	3	This course will study social change in present-day Central and Eastern Europe at different levels of analysis with the aim of understanding the social and cultural characteristics of this region. Special consideration will be given to how much the societies of Central and Eastern Europe are converging with - and still different from - those of Western Europe.
